Notice of Proposed Rulemaking

On May 2, 2017, the New Mexico Department of Game and Fish posted on its website proposed amendments to portions of the Off-Highway Vehicle (OHV) rule 18.15.3 NMAC. The proposed amendments will reflect changes made to the OHV Act by Senate Bill 51 (SB 51) during the 2017 regular session.

Under current rule, all operators and occupants who operate off-highway vehicles on approved streets and highways are required to wear approved helmets. The proposed amendment requires only an operator under the age of 18 to wear an approved helmet while operating on approved streets and highways. An addition to the rule requires operators who wish to operate off-highway vehicles on approved paved streets and highways to have a vehicle plate issued to them by the New Mexico Taxation and Revenue Department.
