NOTICE OF PROPOSED RULEMAKING AND PUBLIC HEARING

The Office of the State Auditor is in the process of amending 2.2.2.1 NMAC, et seq. ("Audit Rule"). The Audit Rule establishes policies, procedures, rules, and requirements for contracting and conducting financial audits, special audits, attestation engagements, performance audits, and forensic audits of governmental agencies of the state of New Mexico, and is governed by Sections 12-6-1 to 12-6-14 NMSA 1978 ("Audit Act"). The amendments to the Audit Rule are proposed pursuant to the Audit Act, Subsection A of Section 12-6-3 NMSA 1978.

Proposed amendments to the rule address the following: modifications to the definition of "Agency" to include joint power agreements; modifications to the definition of "Report" to include "special audit"; modifications to firm profile due date; modifications to the disqualification of firms; modifications for the approval/disapproval of unsigned contracts; modifications regarding independent public accountants' (IPAs) independence requirements; modifications; modifications and new requirements related to the delivery and release of audit reports; modifications to the scope of annual financial and compliance audits; modifications to exit conference and related confidentiality issues; modifications regarding possible violations of criminal statutes in connection with financial affairs: modifications to requirements for school activity funds; modifications to GASBS 77 requirements; modifications to GASBS 75 requirements; modifications to continuing professional education requirements; modifications to special audit confidentiality requirements; modifications to the exemption from

financial reporting; modifications to the requirements related to the review of AUP reports and related workpapers; modifications and new requirements for special audits; modifications and new requirements for annual revenue reporting; modifications and new requirements for progress payments; modifications and new requirements related to report due dates, notification letters. and confidentiality; new requirements for audit findings; new requirements for procurement of IPA service; repeal of schedule of changes in assets and liabilities for agency funds. To the extent applicable, the full text for relevant technical information that served as a basis for proposed changes is available at gasb.org and at gao.gov.

NOTICE OF PROPOSED RULEMAKING

The Youth Conservation Corps Commission (Commission) hereby gives notice that the Commission will conduct a public hearing in Porter Hall on the first floor of the Energy, Minerals and Natural Resources Department, 1220 South St. Francis Drive, Santa Fe, NM 87505 on February 17, 2020 from 9:00am to 10:00am. The purpose of the public hearing will be to obtain input on the proposed amendment to 11.2.171.13 NMAC, The Youth Conservation Corps (YCC) Program and Outdoor Equity Grant (OEG) Programs. Oral and written comments will be accepted at the public hearing; and the hearings will be recorded.

The purpose of this proposed rule amendment is to bring the rule into conformance with the New Mexico Youth Conservation Corps Act, 9-5-B-10.1.F. which defines "applicant" for the purposes of entities eligible to receive OEG funding. The proposed amendment strikes Paragraphs (4) and (7) of Subsection A of 11.2.171.13 NMAC as these exceed the statutory authority, and re-number the section to reflect the deletions. There are no other proposed amendments or changes.

Statutory Authority: The Youth Conservation Corps Act, Sections 9-5B-1 to 9-5B-11 NMSA 1978 (1992, as amended through 2019), specifically authorizes the Commission to "adopt rules that are necessary for the proper administration of the New Mexico Youth Conservation Corps Act, including the outdoor equity grant program."

NOTICE OF PUBLIC RULE HEARING

The New Mexico Medical Board will convene a regular Board Meeting on Thursday, February 20, 2020 at 8:30 a.m. and Friday, February 21, 2020 at 8:30 a.m. and conduct a Public Rule Hearing on Friday, February 21, 2020 at 10:20 a.m. at the New Mexico Medical Board office conference room, located at 2055 South Pacheco St., Bldg. 400, Santa Fe, NM 87505.

The Board will reconvene after the Hearing to take action on the proposed rule amendments. The Board may enter into Executive Session during the meeting to discuss licensing or limited personnel issues.

The purpose of the Rule Hearing is to consider repealing and replacing 16.10. 2 NMAC (Physicians: Licensure Requirements) and 16.10.9 NMAC (Fees). The Board will consider amending 16.10.14 NMAC (Management of Pain and Other Conditions with Controlled Substances) and 16.10.16 NMAC (Administering, Prescribing and Distribution of Medication). The Board will consider promulgating a new rule 16.10.22 (Naturopathic Doctors: Licensure and Practice Requirements). A copy of the proposed rules will available upon request from the Board office at 2055 South Pacheco Street, Bldg. 400, Santa Fe, NM 87505, by phone (505) 476-7220, or on the Board's website at www.nmmb.state.nm.us.

The hearing will be conducted in accordance with the Medical Practice Act, Section 61-6-5. B NMSA 1978, the Uniform Licensing Act Section 61-1-1 through 61-1-31 NMSA 1978, the State Rules Act, Section 14-4-5.3 NMSA 1978 and other applicable procedures.

All interested persons will be given reasonable opportunity at the hearing to submit relevant evidence, data, views or arguments orally or in writing. The New Mexico Medical Board will consider all written comment on the proposed repeal and replacement of 16.10.2 NMAC and 16.10.9 NMAC; the amendments to 16.10.14 NMAC and 16.10.16 NMAC; and promulgation of new rule 16.10.16 NMAC that is submitted to the Board no later than 5:00 p.m. Friday, February 14, 2020. 16.10.2 NMAC Physicians: Licensure Requirements SYNOPSIS:

The proposed replacement of 16.10.2 adds the licensure of out of state sports team physicians. The statutory authority for the New Mexico Medical Board's promulgation of this rule is found in the Medical Practice Act (NMSA 1978, Sections 66-6-1 to -35).

The purpose of the addition of licensure for out of state sports team physicians is the passage of Senate Bill 349 during the 2019 New Mexico Legislative Session. This addition to Part 2 allows for a limited license to be issued by the Board to physicians to provide care to team members and staff traveling with sports teams for a specific sporting event taking place in New Mexico.

16.10.9 NMAC Fees SYNOPSIS:

The proposed replacement of 16.10.9 NMAC adds licensure fees for out of state sports team physicians and Naturopathic Doctors. The proposed replacement also adds licensure reinstatement fees for Anesthesiologist Assistants and Polysomnographic Technologists. There are some additional minor amendments to the reinstatement fee language for Physician Assistants and Genetic Counselors that make the rule consistent for all license types. There is a proposal to change the fee from \$30.00 to \$37.00 for a license verification. The statutory authority for the New Mexico Medical Board's promulgation of this rule is found in the Medical Practice Act (NMSA 1978, Sections 66-6-1 to -35).

16.10.14 NMAC Management of Pain and Other Conditions with Controlled Substances SYNOPSIS:

The proposed amendment to 16.10.14 NMAC updates the rule to require that a health care provider who prescribes, distributes or dispenses an opioid analgesic for the first time to a patient shall advise the patient of the risks of overdose and co-prescribe

an opioid antagonist for opioid prescriptions written for at least a five day supply. The statutory authority for the New Mexico Medical Board's promulgation of this rule is found in the Medical Practice Act (NMSA 1978, Sections 66-6-1 to -35).

The purpose of the amendment to Part 16 is to incorporate mandates set forth in Senate Bill 221 that was passed during the 2019 New Mexico Legislative Session.

16.10.16 NMAC Administering, Prescribing and Distribution of Medications SYNOPSIS:

The proposed amendment to 16.10.16 is to correct a clerical error and take out "supervising physician" from "16.10.16.2 Scope: This part applies to physician assistants and their supervising physician." The statutory authority for the New Mexico Medical Board's promulgation of this rule is found in the Medical Practice Act (NMSA 1978, Sections 66-6-1 to -35).

During the repeal and replacement process for 16.10.16 NMAC in August of 2019 "supervising physician" was inadvertently left in the "Scope" of the rule.

16.10.22 NMAC Naturopathic Doctors: Licensure and Practice Requirements SYNOPSIS:

The proposed new rule sets forth licensing and discipline requirements of Naturopathic Doctors by the New Mexico Medical Board. The statutory authority for the New Mexico Medical Board's promulgation of this rule is found in the Medical Practice Act (NMSA 1978, Sections 66-6-1 to -35) and in the Naturopathic Doctor's Practice Act (NMSA 1978, Sections 61-12G).

The purpose of this proposed new rule is to begin the licensing and regulation of Naturopathic Doctors as set forth by the passage of Senate Bill 135 during the 2019 New Mexico Legislative Session.

Specifically this rule provides duties for the Naturopathic Advisory Council, qualification for licensure as a naturopathic doctor, licensure process, scope of practice, practice limitations, process for disciplinary action, process for license expiration/renewal/change of licensure status, requirements for continuing medical education and exemption from licensure.
