### **BUDGET**

#### FY 2022 Budget

As of May 1, 2022, our general fund balance in the 200 category was \$588,014; the balance in the 300 category was \$290; and the 400 category balance was \$22,270.

#### **DIVISION HIGHLIGHTS**

#### **ALD**

During the third quarter of FY22, all rule updates to the *New Mexico Administrative Code* were published within 30 days. The average number of days between the rule effective date and its online availability was 4 days. In addition, 238 rulemaking actions, 25 notices of rulemaking, and 19 other matters related to administrative law were filed and published by the established deadlines. ALD also provided 3 large group trainings, as well as 3 individual trainings.

#### **RMD**

During the third quarter of FY22, the RMD provided 8 virtual records management and information trainings. The division pulled and processed 290 boxes within 24 business hours. Also, 11,089 units of public records that met their legal retention were validated and processed. There were requests for destruction for 5,217 electronic records and 5,872 boxes.

#### **ITMD**

During the third quarter of FY22, ITMD continued updating the NMAC, SRCA, and OSH websites. Also, meeting notices and video uploads were posted to the agency websites. ITMD responded to 85 helpdesk requests within a 2-hour timeframe and provided support for employees working from home. ITMD provided back-up storage of 102.9 TB of data consisting of 2,123,995 files. In addition, IT supplied 4 desktops and 2 laptops to staff.

#### SANM

During the third quarter of FY22, SANM entered 1,337 descriptive records into HERITAGE. Included were records

pertaining to driving while intoxicated and domestic violence cases in the Bernalillo Metropolitan Court Records (Collection No. 1999-029). In addition, SANM has continued outreach efforts with the New Mexico Public Retirement Association and the New Mexico Jewish Historical Society.

### **OSH**

In support of the Cultural Properties Review Committee (CPRC), the state historian attended a virtual meeting in February. He also attended virtual historic marker CPRC subcommittee meetings in February and March. In the third quarter of FY22, OSH received 150 research inquires. All received responses within 2 business days and were provided full responses within 14 business days. The OSH staff also provided 17 educational activities, which included presentations that were posted to YouTube, Facebook, and the OSH website. In addition, the state historian published 3 "History Matters" articles in the *Santa Fe New Mexican*.
