#### **BUDGET**

## **FY23 Budget**

As of April 1, 2023, our general fund balance in the 200 category was \$547,685; the balance in the 300 category was \$5,644; and the 400 category balance was \$42,572.

#### ROOF PROJECT

On March 20, 2023, DKG & Associates began construction of a new roof at the Carruthers Building. Construction began at the north side, which includes the Santa Fe Records Center, the Records Management Division offices, and the small State Archives of New Mexico vault. Work is anticipated to be completed in this area on June 2nd. Roof construction will then commence on the remainder of the building, which should be completed by the end of the calendar year. State Records Center and Archives and the General Services Department have worked together for quite sometime in making this project a reality. We would like to thank Secretary Doucette, Anna Silva, Marilyn Martinez, and the entire GSD staff for their assistance and continued support.

#### **DIVISION HIGHLIGHTS**

#### **ALD**

During the third quarter of FY23, all rule updates to the *New Mexico Administrative Code* were published within 30 days. The rules were available online an average of 4 days after the effective date. In addition, 68 rulemaking actions, 30 notices of rulemaking, and 3 other matters related to administrative law were filed and published by the established deadlines. The ALD also provided 3 large group training, as well as 6 individual trainings.

#### **RMD**

During the third quarter of FY23, the RMD provided 5 virtual records management and information trainings to 82 public employees. The division pulled and processed 246 boxes within 24 business hours. Also, 28,361 units of public records that met their legal retention were validated and processed. There were requests for destruction for 11,221 electronic records, 957 magnetic cases, and 16,183 boxes.

#### **ITMD**

In the first quarter of FY23, the ITMD continued updating the SRCA and OSH websites with meeting notices, links, and videos. IT also reorganized portions of the SRCA website to remove clutter and improve legibility. The ITMD responded to 58 helpdesk requests within a 2-hour timeframe and provided support for employees working from home. The ITMD provided back-up storage of 121.6 GB of data consisting of 3,873,178 records. In addition, equipment and software were provided in support of all HP Records Manager installations. The division also completed work to develop a customizable search engine for the New Mexico Administrative Code on the agency website with Real Time Solutions.

#### **SANM**

During the third quarter of FY23, SANM entered 928 descriptive records into HERITAGE. Included were records pertaining to driving while intoxicated and domestic violence cases in the Bernalillo Metropolitan Court Records (Collection No. 1999-029). In addition, SANM continued work with KOAT-TV to preserve and digitize 50 original motion picture films.

#### **OSH**

In the third quarter of FY23, the state historian served and provided support to the Cultural Properties Review Committee on February 4th and February 10<sup>th</sup> of 2023. OSH also received 136 research inquires. All received responses within 2 business days and were provided full responses within 14 business days. The OSH staff also provided 12 educational activities, which included 2 articles posted by the state historian about New Mexico history and culture to the OSH web site.
