# COMMISSION OF PUBLIC RECORDS DIRECTOR'S REPORT NOVEMBER 21, 2023

### **PERSONNEL**

The agency has 5 vacancies out of 35 positions. This places our vacancy rate at 14.28 percent.

#### BUDGET

#### **FY24 Budget**

As of November 1, 2023, our general fund balance in the 200 category was \$2,063,059; the balance in the 300 category was \$49,690; and the 400 category balance was \$60,271.

### **DIVISION HIGHLIGHTS**

#### ALD

During the first quarter of FY24, all rule updates to the *New Mexico Administrative Code* were published within 30 days. The rules were available online an average of 3 days after the effective date. In addition, 99 rulemaking actions, 42 notices of rulemaking, and 8 other matters related to administrative law were filed and published by the established deadlines. The ALD also provided 3 large group trainings to 138 people, as well as 6 individual trainings.

#### **RMD**

During the first quarter of FY24, the RMD provided 8 virtual records management and information trainings to 138 public employees. The division pulled and processed 600 boxes within 24 business hours. Also, 23,910 units of public records that met their legal retention were validated and processed. There were requests for destruction for 18,650 electronic records, and 5,260 boxes.

# **ITMD**

In the first quarter of FY24, the ITMD continued updating the SRCA and OSH websites with meeting notices, agendas, and training schedules. The division responded to approximately 124 helpdesk requests within a 2-hour timeframe. In addition, the staff continued to correct issues with the Outlook plugin related to Content Manager. The FY25 Strategic Plan was prepared and submitted with FY25 appropriation request.

### **SANM**

During the first quarter of FY24, SANM entered 472 descriptive records into HERITAGE. Included were records pertaining to driving while intoxicated and domestic violence cases in the Bernalillo Metropolitan Court Records (Collection No. 1999-029). In addition, SANM collaborated with the National Hispanic Cultural Center for an upcoming exhibit. The staff also received a proclamation from the Governor Lujan Grisham designating October as New Mexico Archives Month.

### **OSH**

In the first quarter of FY24, the state historian attended one Cultural Properties Review Committee meeting and two CPRC historic markers sub-committee meetings. OSH also received 125 research inquires. All received responses within 2 business days and were provided full responses within 14 business days. The OSH staff also provided 15 educational activities and conducted two conservation workshops.
