PERSONNEL

The agency has 8 vacancies out of 35 positions, which places our vacancy rate at 23% percent.

BUDGET

FY26 Budget

As of November 3, 2025, our general fund balance in the 200 category was \$2,256,041; the balance in the 300 category was \$25,239; and the 400 category balance was \$44,408.

DIVISION HIGHLIGHTS

ALD

During the first quarter of FY26, all rule updates to the *New Mexico Administrative Code* were published within 30 days. The rules were available online an average of 6 days after the effective date. In addition, 150 rulemaking actions, 50 notices of rulemaking were filed and published by the established deadlines. The ALD also provided 3 large group trainings to 29 people, as well as 38 individual trainings.

RMD

During the first quarter of FY26, the RMD provided 6 virtual records management and information trainings to 123 public employees. The division pulled and processed 518 boxes within 24 business hours. Also, 7,290 units of public records that met their legal retention were validated and processed. There were requests for destruction for 3,619 electronic records, and 3,671 boxes.

ITMD

In the first quarter, ITMD continued updating the SRCA website with current information and assisted the public in resolving site access issues. The division also responded to approximately 42 helpdesk requests within a 2-hour timeframe. In addition, the division hired a network administrator to provide support and consistently maintain the SRCA website.

SANM

During the first quarter of FY26, SANM entered 5,730 descriptive records into HERITAGE. Included were records pertaining to driving while intoxicated and domestic violence cases in the Bernalillo Metropolitan Court Records (Collection No. 1999-029). In addition, SANM continued coordination of the FY26 Archives Month event, in which 13 repositories will participate.

OSH

The state historian attended 1 Cultural Properties Review Committee meetings and 1 Historic Marker Committee meetings in the first quarter of FY26. OSH also received 214 research inquiries. All received responses within 2 business days and were provided full responses within 14 business days. The OSH staff also provided 13 educational, research, preservation, and outreach activities.
