VI. ADJOURNMENT

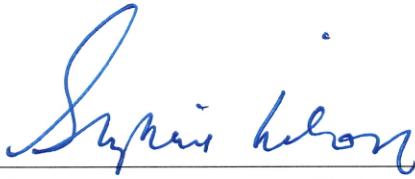
